# General provisions on data protection

We take the protection and security of personal data very seriously. Personal data collected during visits to our websites is always processed in accordance with the relevant statutory provisions. The following explains what type of data we collect and for what purpose:

#### 1. Data transmission/data logging

When you visit our website, our web server collects protocol information on these processes (e.g. type and version of browser, operating system used, referrer URL (page you have come from), IP address, access date and time of the server inquiry and the client's file inquiry (file name and URL). This data is collected for the purpose of statistical analysis and is not personal data. We will not forward your data to third parties unless we are legally obliged to do so.

#### 2. Use of personal data

We will only collect and process personal data when and to the extent that you knowingly and voluntarily provide us with such data. Personal data will be used for the purpose of advertising, informing our customers and utilising our offers only if you have given your express consent. We will not forward your data to third parties unless we are legally obliged to do so.

You have the right to withdraw your consent at any time with future effect.

#### 3. Declaration of consent for advertising information (Newsletter)

Insofar as you wish to receive information on offers and products (Newsletter), we require your e-mail address as well as a confirmation that you are the owner of the stated e-mail address and that you consent to receipt of the Newsletter. This data will only be collected so that we can send you the Newsletter and document our authorisation to do so. We will not forward your data to third parties unless we are legally obliged to do so. You may unsubscribe from the Newsletter and withdraw your consent for storage of your data at any time with future effect without incurring any



costs other than transmission costs in accordance with the basic rates. Notification in the form of a written text (e.g. e-mail, telefax, letter) is sufficient.

### 4. Use of cookies

Our website uses cookies. Cookies are small text files sent to your PC by the web server and usually stored on your hard drive. These cookies do not access information contained on your hard drive and do not impair your PC or your files. Cookies themselves do not store any personal data. When you visit our website again, the cookie indicates that it is a repeat visit. Most browsers are set to accept cookies automatically. However, you can deactivate the storing of cookies or set your browser so that it informs you when cookies are sent.

## 5. Note on Google Analytics

This website uses Google Analytics, a web analytics service provided by Google, Inc. ("Google"). Google Analytics uses "cookies", which are text files placed on your computer to help the website analyse how you use the site. The information generated by the cookie about your use of the website will normally be transmitted to and stored by Google on a server in the USA. However, if IP anonymization is activated on this website, Google will first truncate your IP address within the Member States of the European Union or in other countries that are party to the Agreement on the European Economic Area. Only in exceptional cases will the whole IP address first be transferred to a Google server in the USA and truncated there.
